INTERGOVERNMENTAL AGREEMENT

MUTUAL AGREEMENT FOR SERVICES

Whereas the City of Oglethorpe (hereinafter COO) and City of Montezuma (hereinafter COM) have reached an agreement on a temporary basis for the City of Montezuma Police Department to provide backup and call coverage on 911 calls for the City of Oglethorpe when COO does not have an officer on duty. The City of Oglethorpe agrees for the City of Montezuma's Police Chief, Eric Finch, to have direct oversight of the Oglethorpe Police Officers within the department.

- All COO Officers will report directly to Chief Finch of COM.
- The COO Officers will follow the established protocol and chain of command.
- Both cities' officers will work as one team to provide excellence to both communities as deemed necessary by Chief Finch.
- The COO Municipal Clerk will report directly to the Mayor of Oglethorpe primarily and the Council, secondarily. All requests, directives and/or correspondence regarding Municipal Clerk duties will be directed to the Mayor (and/or council) and relayed to the clerk. All email correspondence will be sent to both the Mayor and Municipal Clerk.
- The COO Mayor and Council will consult with COM Police Chief as needed with regards to budget forecasting and departmental needs assessment in terms of purchasing and contracts.
- COM Chief will give the COO City Clerk and Mayor/Council prior notice before purchasing equipment/essentials needed and before entering any new or amending any current contractual agreements.

The COO will be responsible for paying their current staff and the benefits of four full-time officers, one part-time officer, and one municipal court clerk. The COO will be responsible for gas purchases and maintenance for COO vehicles.

The process for recruitment of new hire officers will be as outlined below. Recruitment of Police Chief will be the sole responsibility of COO Mayor and Council.

- COO Mayor and Council will advertise for new officers utilizing desired platforms. COM
 Chief will receive copies of ads.
- The COO Mayor and Council will review all applications, conduct initial virtual or in-person interviews, and perform previous or current employer reference checks.
- COM Police Chief and Police Captain will conduct background check by Certified Background Investigator
- Polygraph to be conducted by the Georgia Bureau of Investigations. (Required by State Certification)
- Drug Test by local medical facility.
